Non-exclusive, non-transferrable license to use the SDS Template(s)

The “SDS Template(s)” are prepared as ready to use template in MS Word, capturing the headings and sub-headings of the 16 section Safety Data Sheet (SDS) format in line with the legal requirements and using the language specific translations of REACH Article 31 and REACH Annex 2.

The “SDS Template(s)” provided in all relevant EU languages are Intellectual Property (IP) of Onno Jongerius Consult BV. It is developed to the best of our knowledge and expertise currently available. It can be used within your Company to prepare, maintain and distribute your language specific SDS’s in MS Word.

By placing an order on www.reachsupportnetwork.eu and payment of the agreed one-time fee, the Customer has accepted [the generic terms and conditions on the website](#) and these specific terms and conditions. As such, under the agreed terms and conditions, the Customer will obtain a non-exclusive, non-transferrable license to use the SDS Template(s) within his organization.

The “SDS Template(s)” are provided “as is” and in good faith. It can be used, customized and further implemented within your Company upon the user’s own risk and responsibility. If applicable, the “SDS template(s)” must be further completed with the Exposure Scenario (ES) annex.

The Customer has agreed not to reverse engineer, distribute, sell or provide the “SDS Template(s)” in any form to other Parties outside his organization for free or for a financial compensation without upfront contact and full agreement with the product owner Onno Jongerius Consult BV.

The Customer can allow any Third Party (e.g. a Consultant) to support them with the implementation, use and maintenance of the SDS’s prepared from the SDS Templates as long as the SDS Templates and SDS’s prepared from the SDS Templates remain property of the Customer.

The Customer can be a Consultant using the SDS Templates to offer SDS authoring services to his Customers, as long as each Customer supported has ordered his own set of relevant SDS Templates via the REACH Support Network.
